



# Cargo Insurance

Please choose one of the options below:

### Option 1\*

I would like Mohawk Global Logistics to provide "All Risk" cargo insurance to all freight tendered to Mohawk transportation services. For international transportation, the insured value will be calculated based on the total commercial invoice value and freight charges plus 10%.

### Option 2\*

I would like Mohawk Global Logistics to provide "All Risk" cargo insurance to specific shipments only when directed to do so in writing. The written request must be received prior to freight being tendered to Mohawk Global Logistics or authorized agent.

### Option 3

I am declining insurance coverage. I understand the limits of liability is based on the legal liability required based on mode of transport and may be insufficient to provide total financial recovery in the event of a loss. Liability will be based on Mohawk Global Logistics Terms and Conditions:

- Coverage is limited to \$1,000,000.00 (\$350,000 for internal USA and Canada) unless specific written approval.
- The following goods and/or merchandise cannot be insured unless prior written consent is received from the Company and/or Avalon Risk Management: Bank Notes, Currency, Stamps, Jewelry of Value (in excess of \$25,000), Bulk Commodities, Eggs in the shell, Live Animals, Plants, Cellular Phones/Smart Phones, Fruits/Meats/Seafood/Vegetables (fresh), Nuclear Fuels, Cigarettes/Tobacco Related Products, Furs/Valuables, Plasma Televisions, Computer Laptops/Palm Pilots, Gems and Precious Stones, Valuable Papers, Stamps, Computer Memory Chips/Boards, Gold, Silver, Precious Metals, Yachts in excess of \$500,000 and/or 40'.
- Embargoed Areas. There is no insurance available on our policy for shipments to or from any of the following restricted and/or embargoed countries in the World that are cited by the United States Government through the Office of Foreign Assets Control (OFAC) and/or the UN Embargoed Countries. Current list of embargoed areas are available on OFAC's website at [www.treas.gov](http://www.treas.gov) and currently include, subject to change: Afghanistan (Taliban), Iran, North Korea, Angola (UNITA), Iraq, Sierra Leone, Balkans, Ivory Coast (Cote d'Ivoire), Somalia, Belarus, Liberia, Sudan, Burma (Myanmar), Libya, Syria, Cuba, Mexico (truck or rail), Zimbabwe, DRC Congo (Zaire), Nigeria.
- Restricted Countries may be covered with limitations: On shipments TO the following countries (Exports)-Coverage to cease upon discharge of goods from overseas carriers. On shipments FROM the following countries (Imports)-Coverage to commence upon loading of the goods on the overseas carrier: Armenia, Kyrgyzstan/Kirghizia, Tajikistan, Azerbaijan, Latvia, Turkmenistan, Estonia, Lithuania, Ukraine, Georgia, Moldova, Uzbekistan, Kazakhstan, Russia.
